This being normal for children, we undertake that should such issues occur, we will familiarise ourselves with all necessary details, and where appropriate; we will correct my child and support the staff. We will approach the correct staff members to obtain all the necessary details.

- We further realise that building strong relations with our child's teachers to aid in the training of our child is as much our responsibility as it is the school's, and we will pray for the staff and the school programme, co-operate with them in the discipline and accept that the staff will attempt to display fair judgment in all matters.
- We will lay a spiritual foundation through Godly example in the home and support the spiritual training in the school.
- We will follow through with any work, assignments or communications to be signed.
- We will undertake to ensure that our child abides by the school's times.
- We will undertake to ensure that we will co-operate in training the child to respect the school property and pay for irregular abuse of same.
- We will send written reasons for absence or tardiness.
- We will attend all parent functions, and see to it that our child's appearance conforms to the school regulations.

Bus Rules

- Learners are only allowed to use the bus once their parents have signed the indemnity form and returned it to school.
- Learners are not allowed to board or get off the bus while it is still moving or if the engine is still
 running. Only once the bus had come to a complete stop and the engine had been switched off,
 learners may board or get off.
- Learners may not board the bus at school before the bus teacher added them to the register.
- Learners are not allowed to stand, walk or run in the bus while it's moving. Learners should remain seated.
- Learners must not make excessive noise on the bus as it is distracting to the driver.
- Learners are not allowed to hang out the windows or doors of the bus.
- Learners are not allowed to litter in the bus, nor to throw litter out of the windows.
- Learners may not eat or drink on the bus unless the bus teacher had given permission.
- Learners may not damage anything on the bus. In case damage occurs due to maliciousness or negligence, the learner in question's parents will be held liable for all repair costs.
- Learners are responsible for their own belongings on the bus and must ensure that they do not leave anything behind.
- Learners must know where to get on and off the bus.
- The Code of Conduct still applies on the bus and learners who misbehave will be punished.
